Minutes of a Meeting of Steventon Parish Council held on Tuesday 1st November 2016 in the Village Hall Millennium Room

1. APOLOGIES FOR ABSENCE

Apologies were received from Mr J Bennett and PCSO Gary Kirby

2. PRESENT

Dr C Wilding (Chairman), Mr R Bosley, Mr J Clark, Mrs C Denton, Mr R Green, Miss L Humphries, Mr J Spiller and Mr R Wilkinson. Mrs A Einon (Parish Clerk), Cllr M Barber (VWH) and Cllr S Lilly (OCC) were in attendance. There were nineteen members of the public present.

3. DECLARATIONS OF PECUNIARY INTERESTS AND OTHER DECLARATIONS

To receive any declarations of disclosable pecuniary interests, and other declarations, in respect of items on the agenda for this meeting.

There were no declarations.

4. PUBLIC PARTICIPATION

4.1. GARD

Derek Stork updated the meeting on the current position of Thames Water regarding the reservoir. In 2010 after a public enquiry Thames Water were defeated in their plan to build a reservoir covering 4 square miles with 100 foot embankments. They were told to justify, show the need and investigate all other sources. Thames Water's latest proposals include a reservoir the same size as that dismissed previously possibly done in 2 phases which would extend the disruption to twenty years. It is likely that the reserved area at Longworth for a smaller reservoir will be removed. The proposed reservoir is the same size as that held by the Mona Dam destroyed in the second world war! GARD require volunteers and support.

4.2. Railway electrification

Gantries are going up and approaching Steventon from both directions. Nothing further has been heard from Network Rail about the proposal to lower the track nor the application to the Department of Transport to close Stocks Lane crossing. Cllr Lilly was working on the links between OCC, the Parish and Network Rail. OCC had looked at the bridge though not a proper survey but it suggests that work is required.

Chris Wilding had personally written to Network Rail to ask for copies of key documents. Mr. Robson had received a letter from Ben Vosper, Senior Surveyor, Network Rail, regarding options for negotiations of the acquisition of land. It seems that as always one part of Network Rail has no idea what the others are doing!

The Parish Council would like to thank all residents that had written to object to the plans.

4.3. Chicane Hanney Road

There is a proposal under consultation at present to take out one side of the chicane in the Hanney Road. This would mean that HGV's could fit past without demolishing the keep left on a regular basis, priority would be for those leaving the village and a bicycle bypass would be part of the design.

5. REPORT FROM ANY COUNTY OR DISTRICT COUNCILLOR IN ATTENDANCE

Clir Matthew Barber. Linden 3 has been issued with a stop notice that will be effective until 28th November, hopefully time to resolve the issues. If the conditions are complied with work will recommence, if not further stop notices cannot be issued but the Vale will go to court for an injunction. SuDs are going to be investigated, what has been done so far and make sure future are fit for purpose. Planning cannot be refused on SuDS only conditions included and because changes to the flood act were not adopted no one is responsible for maintenance. Longworth reservoir will stay at present as it is in the Local plan.

There have been issues with bin collection in that the fleet is old, Biffa have put in place a plan to replace.

Cllr Stewart Lilly. Attempting to arrange a meeting with OCC, Network Rail, the Parish Council representatives and Ed Vaizey to discuss the bridge, talking round a table would lead to a coordinated response instead of chasing letters. Didcot Garden Town holding an Open Day on 9th November at the Cornerhouse Arts Centre in Didcot. It

was hoped that the cooperation of the Vale and South Oxfordshire on this would enable money to be obtained from the government.

Two volunteers had come forward to make enquiries about fostering or adopting in the Parish.

Ed Vaizey had been involved in the A34 action group and it was hoped that something would be proposed. The Oxford to Cambridge expressway which goes through all strategic areas of growth is proposed to reinstate the railway link closed by Beeching.

Mr Habgood the new Police and Crime commissioner for the Thames Valley has reported that the Police will be losing their helicopter which will be replaced by a fixed wing plane. Cyber-attacks are increasing and need more funds, antisocial behaviour has gone up by 30%. The police cadet force is to be reinstated. Drug dealing cartels are coming to the countryside, gangs from London and Bristol hire properties for sourcing.

The Chilton slips are due to open on 10th November.

6. APPROVAL OF THE MINUTES OF THE LAST MEETING

The minutes of the meeting held on Tuesday 4th October, 2016, were accepted as a true record, with the removal of Mr Wilkinson from those present. 4.3 remove "on the". 7.6 change to … moved. It would be incorporated… 11.9 replace the sentence with: A site assessment of areas in the village for possible future housing was not proving robust enough to challenge developers. Proposed: Mr Clark. Seconded: Miss Humphries.

7. MATTERS ARISING FROM THE MINUTES OF THE PREVIOUS MEETING – REPORTS ON ACTIONS

7.1. Registration of Parish Council Land

Mr Green proposed to put an appeal in Steventon News for long term residents, more than 25 years, to write a statement about land usage and maintenance in the areas for registration.

7.2. Ditch clearance programme

Mr Wilkinson had passed on the information regarding bank cutting for the benefit of voles. The Warden would be advised to cut alternate sides of the ditches with water flowing to facilitate the voles' habitat.

7.3. Flood contingency Plan

7.4. Traffic calming

The monitor in the Hanney Road appeared to be responding slowly. This would be checked.

7.8. Hanney Road

Approximate costs provided by County to install a zebra crossing £30,000 to £40,000 or a puffin crossing (with lights) £60,000 to £80,000, both would require extensive research on current speeds, exact location, and usage. Data from 2012 indicated average speed of 35 mph which is more than that suitable for a zebra. Results from the Parish traffic monitor suggest that due to the speeds reached in the Hanney Road a puffin crossing would be necessary, unless additional calming were installed i.e. pillows, at an approximate cost of £15k each, to slow the traffic. A requirement of 20 metres from an existing side road would be decisive on location.

Parents are using their cars to get across the village to bring children to school because of the dangerous roads. A possible school patrol officer was suggested. The infrastructure working group to discuss futher.

7.9. SuDS

A response dated 18 October had been received from Emma Turner at the Vale attaching a report by Monson in answer to our HR Wallingford investigation. Both reports are available to read on the Neighbourhood Plan page of the website. Click to open link <u>Reports</u>. The response is very concerning as it appears that no provision is made for future maintenance and little if any checking is done on the installation. The Vale promise to address the situation.

7.10. Linden 3

See above under 5. Investigations to be carried out by the Enforcement Officer of the Vale on the drainage installed and in collaboration with OCC Highways on the road installation. Residents would send any information of breach to the Enforcement Officer.

7.11. White lines Stonebridge Road

The Clerk had reported to Highways the lack of markings on roads leading into Stonebridge Road.

7.12. Field Gardens

The Clerk had reported to the PCSO who would keep an eye out for obstructing vehicles.

7.13. Grass cutting

The Open spaces working group had met with Laura Payne-Hutchins (OCC) to discuss grass cutting in the parish. OCC currently employ Scanska. A map provided of the areas cut by Skanska under the contract appeared to cover a lot of areas that are maintained by the residents of the village or Sarinc. They are currently paid £1774 pa the

County would pay the Parish a similar amount but wold require the grass to be cut twice a year rather than the once on the current contract. A blank agreement would be supplied to enable further investigations to be made. The agreement would be sent to the Parish Insurers to ensure that any work would be covered. There was also a possibility of extending the cutting to the Parish boundary at so much a metre. Open spaces would consider the map and the locations.

8. PARISH REPRESENTATIVE FOR PAROCHIAL CHARITIES

Mrs Francis Silk had written to tender her resignation as a Parish representative on the Parochial Charities. Mrs Silk has worked tirelessly for many years in this role and the Parish Council would like to thank her for the many hours she had put into the role. Discussion as to a successor suggested that a current Sarinc trustee may take on the role to extend the links between the charities in the village and the Parish Council. 9. OPENING GROVE RAILWAY STATION

Recent items in the local press reported that Ed Vaizey was supporting the reopening of Grove Railway Station. The Parish Council agreed that a letter should be sent expressing their concern that a reopening would affect our village in that an increase in the speed and frequency of trains, affects the level crossings. Already the crossings can be closed for up to forty minutes in any one hour and this will increase with electrification. Mr Bosley agreed to draft a letter to be sent by the Clerk.

Both had indicated their willingness to stand for a further four years. The Parish Council was delighted to accept their offer and extend for a further four years until 17 January 2021.

11.9. Neighbourhood Plan RB, RG, JC, JS, CW, Clerk and volunteers: Lorraine Atkins, Laura Bosley, Nigel Goode, Avril Ivin, Nick Thompson

The Steering Group met with the Vale and County Officers led by Andrew Maxton(Planning). Issues to address: the Neighbourhood Plan route to take and cheaper ways to reach the objective. Notes and recommended paperwork yet to be received but it seemed likely that a change of course, not to do specific site assessments, but to do a detailed character assessment, would be the outcome. The Neighbourhood Plan working group would meet and discuss the implications. The Parish Council will decide the amount of money to be spent, the £10k grant from the Vale will be honoured which will cover the expenditure to date. A Locality grant may provide more funding. CFO have revised their quote from £12.5k to a core £6.5 with further support optional.
